STOP Unfair Labour Practice at Nagoya International School!

### 名古屋国際学園の不当労働行為に抗議を!

The General Union is currently in a dispute with Nagoya International School over a member who was non-renewed after filing a sexual harassment complaint and declaring union membership. The Union has engaged in collective bargaining with

the school as well as filing a suit against them at Osaka Prefectural Labour Commission. This pressure has precipitated changes at Nagoya International School, and the Union has won unlimited term contracts for staff and national insurance for all. 名古屋市守山区にキャンパスを持つ名古屋国際学園(Nagoya Internation-
